Executive Summary

Statement of Financial Position

This statement is often referred to as the *Balance Sheet*, and it is designed to represent an organization's total assets available to meet its obligations (liabilities) as of a specific point in time. The difference between total assets and total liabilities is referred to as *Net Assets*, or *Equity*.

- Cash decreased by \$2,100 from the prior month, while net loss for the month was \$13,100. The primary driver of this discrepancy is unrealized gains on investments, which affect net income but not cash.
- Prepaid expenses of \$15,300 represent a series of deposits related to future annual conferences and some annual subscriptions which will be expensed over the course of the year.
- The value of investments decreased by \$12,500 since last month, this is primarily due to the unrealized losses on investments.
- Deferred revenue of \$2,500 represents prepaid membership fees which relate to future fiscal years.
- The \$55,000 balance of the Permanently Restricted Net Assets account represents the endowment balance.

Statement of Activities

This statement is often referred to as the *Income Statement* or *Profit and Loss*, and it is designed to represent an organization's accrual-basis revenue and expenses over the course of a specified period. The difference between total revenue and total expenses is referred to as *Net Income*, or *Earnings*.

- The organization recorded \$4,600 in revenue for the month. This can be primarily attributed to the conference revenue. Revenue for the fiscal year is \$10,300, which is composed of conference and membership revenue.
- Total operating expenses during the month were \$5,300, which consisted primarily of professional services and payroll expenses. Year to date operating expenses total \$36,000.
- There was a net operating loss of \$700 for the month.
- After accounting for non-operating investment activity there was a net loss of \$13,100 for the month, while the net income for the year is \$18,600.
